Re: September 1, 2026 Notice of Estimated Distributions for 2026

The Pennsylvania Opioid Misuse and Addiction Abatement Trust (“Trust”) is pleased to report that estimated distributions to Counties, Litigating Subdivisions, and the Commonwealth for the next distribution cycle have been calculated.¹ Capitalized terms used herein are as they are defined in the Commonwealth Court Order entered October 15, 2024 (the “Amended Trust Order”). ESTIMATED DISTRIBUTIONS FOR 2026

Attached to this Memorandum is an Excel file that provides estimated distributions for 2026 to each County and Litigating Subdivision recipient, as well as the Commonwealth’s distribution. These are estimated distributions and are subject to change due to payment of expenses such as administrative and litigation costs as well as the possibility of receipt of settlement funds from additional sources before disbursement occurs later this year. This spreadsheet, however, provides a reasonable estimate of what each recipient will receive.

Payment 6 Breakdown – Reflects distributions to be received from both the County Abatement Account (Amended Trust Order ¶ II.1.b.) and Litigating Subdivision Account (Amended Trust Order ¶ II.1.c). Costs and attorneys’ fees, as required by the Amended Trust Order, are also reflected.

CERTIFICATIONS DUE BY NOVEMBER 15, 2026

Also attached hereto are the blank certification forms for Counties (Amended Trust Order ¶ V.D.3.; Exhibit 2) and Litigating Subdivisions (Amended Trust Order ¶ V.D.4.; Exhibit 3) to use for funds to be distributed from the County Abatement Account and the Litigating Subdivision Account, respectively. These must be submitted in completed form no later than November 15, 2026, to administrator@paopioidtrust.org.

¹ Pursuant to Section V.D.6. of the Amended Trust Order, distributions to Participating Subdivisions will occur on or about December 15, 2026, and distribution to the Commonwealth will occur on about June 15, 2027.

The Trust has worked and continues to work diligently to distribute all available settlement funds as quickly and efficiently as possible. In this regard, the Trust appreciates the cooperation and support of the Counties, Litigating Subdivisions, and Commonwealth of Pennsylvania.
