Prevent Misuse of Opioids 	1	Club One Day at a Time (ODAT) was created to provide a stable and consistent environment for members of various recovery programs in the Adams County area to hold meetings and help each other recover from OUD and other substance use disorders. Location stability for members of such groups is a challenge, due to changes or disruptions from the entities likely to host recovery meetings, such as churches or community centers. This, in turn, affects newcomers' abilities to find meetings and regular attendees' continued participation. Club ODAT provides permanency which assists with these hurdles. Currently, Club ODAT has 18 independent meetings, serving over 650 attendees monthly. These meetings are critical for recovery and are open to anyone suffering from OUD/SUD and their loved ones. It will be capable of delivering drug prevention content and critical services to isolated communities. This targeted public health messaging effort was designed for our specific rural geographic area and was geared toward college-aged individuals and our large Hispanic population. Media is in both English and Spanish and is displayed at locations such as churches, convenience stores, gas stations, grocery stores, laundromats, restaurants and bars. The goal of the campaign is for citizens to encounter the messaging multiple times as they go about their daily lives. This campaign focuses on naloxone awareness, treatment resources, recovery support and stigma reduction. Success is measured by increased naloxone distribution, improved public knowledge and reduced overdose deaths. The program provides rapid support at critical moments following overdose reversal, ER discharge, or completion of inpatient treatment. The pilot will implement a Direct On-Scene Response Team available from 10AM to 10PM Monday through Friday, along with a 24/7 Toll Free Line manned by trained Certified Recovery Specialists (CRS) to coordinate warm hand-offs. Participants will receive individualized recovery navigation and wraparound support, including linkage to MAT, housing, transportation and employment resources. This model is particularly valuable in rural communities where access to services is limited. By prioritizing immediate engagement after overdose, the model reflects evidence that early connection to recovery support reduces mortality and improves recovery outcomes.	3	Approved

This shelter will provide safe, stable housing and access to recovery-oriented support services, helping to break the cycle of addiction, trauma, and homelessness. Women entering the program will be connected to treatment and recovery programs, counseling, life-skills training, and case management through partnerships with local agencies specializing in OUD treatment and prevention. These new drugs are causing massive comorbidity issues physically that coincide with the typical detox nature of treatment. These complications require hospital-based care only. Because these individuals are not insured, this expense goes unpaid by OUD consumers which causes financial strain on the hospital. We have agreed to help reimburse the hospital for each OUD consumer that cannot medically pay for their treatment. As part of payment, the hospital has agreed to hire and provide a Recovery Specialist that will work on our behalf to ensure the consumers, once medically cleared, can be transferred to non-hospital inpatient services.
